1. LAWS, DECISIONS OF THE PARLIAMENT, DECREES OF THE PRESIDENT

1.1. LAW NO. 284 OF 28 DECEMBER 2011 ON AMENDMENT AND COMPLETION OF CERTAIN LEGISLATIVE ACTS

In accordance with the Law no. 275 of 27.12.2011 the Republic of Moldova adhered to the Convention relating to the status of stateless persons. Next day the foregoing law has been approved, the Parliament approved the draft law, which was developed by Ministry of External Affairs and European Integration, and which concerned the operation into the legislation of the Republic of Moldova of necessary modifications to implement aforementioned Convention. Namely, there have been operated essential modifications and completions in the Law no. 200 of 16 July 2010 regarding the status of foreigners in the Republic of Moldova, and also have been respectively adjusted the Laws no. 275-XIII of 10 November 1994 regarding the legal status of foreigners and stateless persons in the Republic of Moldova, no. 273-XIII of 9 November 1994 regarding identity acts in the national passport system, and no. 1024-XIV 2 June 2000 on citizenship.

2. DECISIONS OF THE CONSTITUTIONAL COURT

2.1. DECISION NO. 2 OF 24 JANUARY 2012 ON APPROVAL OF THE REPORT REGARDING EXECUTION OF CONSTITUTIONAL JURISDICTION IN 2011

According to the Report in 2011 the Constitutional Court (CC) examined 49 complaints (10 of them dated back from 2010), of which 44 were solved and 5 postponed for examination in 2012. The Report also contains the statistical analysis of the authors, the object matters of the complaints and the summary of the decisions adopted by CC in 2011.

3. DECISIONS OF THE GOVERNMENT

3.1. DECISION NO. 68 OF 2 FEBRUARY 2012 ON AMENDMENT, COMPLETION AND ABROGATION OF CERTAIN GOVERNMENT DECISIONS

The decision updates a set of governmental acts covering the legal regime of the objects of intellectual property. Thus, according to the decision the following acts were amended: the Regulation on estimation, approval and purchase of literary works approved by Government Decision no. 1312 of 28 December 2000 (1), the Catalogue of fixed assets and nonmaterial actives, approved by

Government Decision no. 338 of 21 March 2003 (2), the Regulation on the order of production, issue and application of control markings on the copies of works and phonograms and the Regulation on the order of registration in the State Register of the holders of control markings, approved by Government Decision no. 744 of 20 June 2003 (3), and the Regulation on estimation of the objects of intellectual property, approved by Government Decision no. 783 of 30 June 2003, (4) etc.

3.2. DECISION NO. 78 OF 8 FEBRUARY 2012 ON APPROVAL OF AMENDMENTS AND COMPLETIONS TO THE CERTAIN GOVERNMENT DECISIONS

According to the Decision the amount of an allowance to be paid for a newborn to the insured and non-insured persons increased in 2012: for the first newborn from 2000 MDL to 2300 MDL, and for the following newborn children from 2300 MDL to 2600 MDL.
