1. LAWS, DECISIONS OF THE PARLIAMENT, DECREES OF THE PRESIDENT

1.1. LAW NO. 227 OF 25.11.2011 ON AMENDMENT AND COMPLETION OF CERTAIN LEGISLATIVE ACTS

The law aimed at adjusting a number of Moldovan laws concerning the state social security payments to the recently-passed reform of the social security legislation (enacted through the law no. 56 dated 09.06.2011, published on 01.07.2011 – VB).

1.2. LAW NO. 228 OF 25.11.2011 ON AMENDMENT AND COMPLETION OF THE LAW NO. 939-XIV OF 20.04.2000 ON PUBLISHING ACTIVITY

The Law has been substantially amended and completed to cover and regulate such concepts as republishing, new edition, copyright of the publisher etc. The amendments liberalized access to publishing activity on the territory of the Republic of Moldova for non-residents.

1.3. LAW NO. 229 OF 25.11.2011 ON AMENDMENT OF CERTAIN LEGISLATIVE ACTS

The law aimed at adjusting a number of Moldovan laws to remove the double citezenthip as ground for dismissal of certain categories of civil servants.

2. DECISIONS OF THE CONSTITUTIONAL COURT

2.1. DECISION NO. 28 OF 22.12.2011 ON THE CONSTITUTIONAL CONTROL OF THE LAW NO. 184 OF 27.08.2011 ON AMENDMENT AND COMPLETION OF CERTAIN LEGISLATIVE ACTS

Through its decision the Constitutional Court (CC) recognized as contrary to the Constitution the Law no. 184 of 27.08.2011 on amendment and completion of certain legislative acts, approved by the Government of the Republic of Moldova on the basis of the art. 106¹ of the Constitution. The CC decided that while in principle the Government is entitled to use the provision of art. 106¹ in emergency cases to pass laws through engaging its liability toward the Parliament, such use is contrary to the art. 106¹ of the Constitution if exercised during the Parliamentary holidays.

3. DECISIONS OF THE GOVERNMENT

3.1. DECISION NO. 1020 OF 29.12.2011 ON TARIFFS ON MEDICAL-SANITARY SERVICES

The title of the decision is self-speaking.

4. DECISIONS OF THE MINISTRIES AND OTHER CENTRAL PUBLIC ADMINISTRATION AUTHORITIES

4.1. ORDINANCE OF THE MINISTER OF FINANCE NO. 159 OF 30.12.2011 ON AMENDMENT AND COMPLETION OF BUDGET CLASSIFICATION

The ordinance approved certain amendments to the BUDGET CLASSIFICATION of revenues and expenses.

4.2. DECISION NO. AT-9/1 OF 22.12.2011 OF THE THE NATIONAL ATTESTATION AND ACCREDITATION COUNCIL ON AMENDMENT AND COMPLETION OF THE REGULATION ON OPERATION OF THE SPECIALIZED SCIENTIFIC CONCILS AND AWARD OF SCIENTIFIC TITLES

The Regulation has been completed to extend the scope of the Regulation toward research scientific institutions, and provided liability for academic tutors of research papers.

4.3. DECISION NO. 5 OF 15.06.2011 OF THE NATIONAL COUNCIL FOR THE GUARANTEED LEGAL ASSISTANCE ON APPROVAL OF THE REGULATION ON THE ACTIVITY OF PARALEGALS

The regulation provided the legal framework for operation of paralegals – persons enjoying the respect of the local community, having uncomplete or no legal education yet higher education and having passed the legal education courses to provide primary legal aid to local community members.
