1. DECISIONS OF THE GOVERNMENT

- 1.1. DECISION NO. 32 OF 13.01.2012 ON AMENDMENT AND COMPLETION OF THE REGULATION ON THE ORDER OF APPROVAL AND REGISTRATION OF FACTORY PRICES ON DRUGS

The Decision amended and completed the foregoing Regulation, to detail the procedure of reporting to the National Agency for Drugs of the factory prices on drugs and their reflection into the on-line centralized database of prices.

2. DECISIONS OF THE MINISTRIES AND OTHER CENTRAL PUBLIC ADMINISTRATION AUTHORITIES

- 2.1. ORDINANCE NO. 2 OF 12.01.2012 OF THE MINISTRY OF FINANCE ON APPROVAL OF AMENDMENTS AND COMPLETIONS TO THE METHODOLOGICAL NORMS FOR EXECUTION OF STATE BUDGET THROUGH TREASURY ACCOUNTS OF THE MINISTRY OF FINANCE

The ordinance adjusted the ordinance of the Ministry of Finance no. 98 of 28.11.2005 to the amendments passed by the Ordinance no. 1 of 03.01.2012 on the order of performance and evidence of payments to the national state budget through the treasure system of the ministry of finance in the year 2012 (as published in the Official Gazette no. 13-14 of 13.01.2012).

- 2.2. ORDINANCE OF THE MINISTRY OF AGRICULTURE AND FOOD INDUSTRY NO. 06 OF 16.01.2012 ON USE OF CERTAIN NORMATIVE DOCUMENTS OF THE EUROPEAN UNION AND RUSSIAN FEDERATION NECESSARY FOR EVALUATION OF CONFORMITY OF ALCOHOLIC PRODUCTION

As a provisional measure to avoid the technical issues resulting from discrepancies between domestic (from one hand) and EU and Russian Federation's ones (from the other hand) with respect to the quality of alcoholic production, the ordinance set forth a list of standards of EU and Russian Federation to be applied to evaluate the conformity of alcoholic production.

- 2.3. ORDINANCE NO. 381 OF 13.05.2011 OF THE MINISTRY OF HEALTH ON AUTHORIZING OF IMPORTS/EXPORTS OF BLOOD PRODUCTS

The ordinance enacted the Regulation on authorizing the exports or imports of blood products, the documents to be submitted or produced in this respect, as well as approved the composition of the Commission of authorization of said imports/exports.

- 2.4. DECISION NO. 34 OF 01.12.2011 OF THE NATIONAL AGENCY FOR REGULATION OF ELECTRONIC COMMUNICATIONS
